JUNK VEHICLE REMOVAL PROGRAM

FREE SERVICE PROVIDED FOR ALLOWABLE VEHICLES

- This program reimburses a hauler for removing a junk vehicle from private property
- This program will continue through June 30, 2025 or until funding is depleted
- Up to 3 vehicles per parcel per fiscal year can be removed, as the budget allows and is non-transferable
- This program applies to passenger vehicles and/or pickup trucks that do not exceed 15,000 lbs
- Vehicle must be free of debris and garbage

Initial Request for Removal

- A request can be made by any Borough resident regarding a junk vehicle on their private property
- You may download a form and follow the directions by using this QR code
