Damsel is shelved in the Young Adult (YA) sections at all three libraries. This book is a coming-of-age story that intends to tackle challenging themes with a female protagonist.

The material is a book format. Books make up the majority of inventory in all five of our public libraries.

#### Has the material been used frequently by patrons?

This factor depends on the library due to the size of the collection, the size of the library and length of time one patron maintains the book.

- Sutton Library shelved the book in 2019 and has been checked out seven (7) times. This is a medium rate of check out for a YA collection in a library the size of the Sutton Library.
- Willow Library shelved the book in 2018 and checked out thirteen (13) times. This is a medium rate of check out for a YA collection in a library the size of the Willow Library.
- Big Lake Library shelved the book 2023 and checked it out one (1) time. This is a low rate of check out for the YA collection in a library the size of the Big Lake Library.

This book is a work of fiction and not a resource material.
