Is the material in good condition or appearance?

Yes, it is in good condition.

Is the topic of the material a priority for the collection?

Anne Frank's Diary, the Graphic Adaptation is shelved in the Young Adult (YA) section at the Talkeetna Library. Young Adult collections are responsive and tend to reflect the age and stage of life of the intended reader.

This book is a graphic novel which is a popular storytelling format in YA collections. Graphic novels tell a story primarily through sequential art panels, combining text and illustrations to convey narrative, and intends to engage readers through visual storytelling and provide a unique way to explore diverse themes and perspectives.

Is the format of the material a priority for the collection?

The material is a book format. Books make up the majority of inventory in all five of our public libraries.

Has the material been used frequently by patrons?

This factor depends on the library due to the size of the collection; the size of the library and length of time one patron maintains the book.

This book was added to the collection on December 18, 2018 and has been checked out a total of 13 times. Which is a moderate rate of use.

Is the material factually accurate?

This book is an adaptation of the original Diary of Anne Frank and is the perspective of WWII and the Holocaust from a young girl .

Has the material been superseded by a new edition or a better source?

There are many adaptations and versions of The Diary of Anne Frank. The original book has been translated in 70 different languages.

Is the material relevant to the needs and interests of the community?

Anne Frank's Diary, the Graphic Adaptation is a version of the original novel by Anne Frank. The original book sold over 30 million copies and is one of the most read books in the world. This graphic adaptation makes the story relevant to the times and could engage new readership that would not read the text

narrative book.

Can the material be easily borrowed from another source?

It is available at all the Borough libraries through our participation in the State Library Catalog as well as an E-Book through the Alaska Digital Library.

What is the literary, artistic, scientific, political, or educational merit of the material.

The book is an adaptation of the original Diary of Anne Frank and highlights World War II, the Holocaust and other historical references. This book is the only graphic biography of Anne Frank's diary that has been authorized by the Anne Frank Foundation and that uses text from the diary.

Does the material have positive review(s) in one or more appropriate professional journals? A brief selection of reviews can be found in the <u>School Library Journal</u>-Good Comics for Kids or in the <u>Statewide Library Electronic Doorway</u>.

Are there sufficient materials available on the same subject?

There are many books detailing WWII and the Holocaust, but few, if any from the perspective of a young Jewish girl and this is the only sanctioned graphic novel adaptation of the original book.

Does the material have a reputation and/or significance of the author, publisher or producer?

Anne Frank's Diary: The Graphic Adaptation has won multiple awards and honors, including Best Jewish Children's Book of 2018. It was also a Junior Library Guild Selection from 2012 to 2025.
